The first 50 Founding Individual Memberships are accessed with:

1-50	\$1,000 initiation fee and \$1,000 in annual dues (annual dues fixed for two (2) years).
51-100	\$1,250 initiation fee and \$1,250 in annual dues (annual dues fixed for two (2) years).
101-150	\$1,500 initiation fee and \$1,500 in annual dues
151 +	\$1,750 initiation fee and \$1,750 in annual dues

Corporate Memberships recognize a minimum of two (2) individuals as Primary Members which include memberships for spouses and a minimum of two (2) associate corporate members, spouses membership not included. Corporate-rate Memberships are subject to availability, the consent of Management, and a demonstrated business relationship between the Members. Primary Corporate Memberships are accessed with a \$1,750 initiation fee and \$1,750 in annual dues and the additional associated corporate Members are accessed at \$1,250. annually. Corporate Memberships with three or more primary Members are accessed with a \$1,250 initiation fee and \$1250. in annual dues per person. All Memberships are subject to Management consent and discretion.

House Rules

It is the intent of Management to limit these rules and regulations to the minimum required for the mutual enjoyment of the Club by all its Members and their guests. The obligation to monitor these rules is placed primarily in the hands of a carefully selected, trained staff whose principal responsibility is to assure you of all the courtesies, comforts, and services to which you, as a Member of the Capital Club, are entitled. It is further the duty of the membership to know the Club's rules and cooperate with the Board and staff in the enforcement thereof.

Orientation Member Privileges will be activated upon completion of the new member orientation, which is scheduled with the Membership office. It is an opportunity for Members to review the benefits of Membership and become acclimated with Club facilities.

Membership Numbers Members should acknowledge all orders for food, beverage, and service by legibly signing their name and membership numbers. The signing of the membership number assists the Club's accounting office in keeping proper records. Members who would like to exercise guest pass privileges should contact the membership office. Membership numbers should not be given out to non-members for use.

Guests Fully-privileged members may introduce guests to the Club at any time, provided they are accompanied by the Member. Guests may receive a guest card on request of the Member with prior arrangement. Each membership is allowed to extend 6 Guest passes per year, with this privilege being extended to the same guest only twice in their lifetime. Members are responsible for their guest's conduct and all charges incurred by their guest. Guest passes can be arranged by contacting the Membership office.

Reservations To better serve Members, the Club strongly recommends reservations for lunch and dinner. The Club will honor reservations up to fifteen minutes beyond the time of reservation. Seating without a reservation will be done when possible. The Club's private dining rooms are available on a reservation basis for business meetings, conferences, receptions and private parties.

Surcharge For your convenience, an automatic 20% surcharge is added to all food & beverage charges. 15% is divided amongst the service team and 5% is a Club administrative fee. Star Cards are available in the Club for your specific recognition of individual employee partners, if desired. **Dress Code** Dress will be business casual-no coat and tie required. However, athletic shoes, shorts or tee shirts will not be permitted.
